Subject:-Implementation of the recommendations of the sub-committee for accepting data generated and certified by GLP/NABL accredited Labs for the purpose of Registration of Pesticides.


The Registration Committee in its 421st Meeting held on 21.8.2020 after deliberations on the recommendations of the sub-committee for accepting data generated and certified by GLP/NABL accredited Labs for the purpose of Registration of Pesticides has decided to the implementation of the following:-

- (i) Inspection and approval of GLP/NABL accredited Laboratories, henceforth, is not required by CIB&RC;
- (ii) Chemistry, residue, persistence and packaging data generated by the GLP/NABL, accredited Laboratories/Institutions may be considered for registration of pesticides;
- (iii) While applying for the grant of registration, the applicant should enclose copy of GLP/NABL certificate of the lab from where chemistry, residue, persistence and packaging lab data has been generated;
- (iv) For development of better quality of pesticides and making them acceptable globally, regulatory system should steadily advance towards adopting GLP practices.

2. It will be the responsibility of GLP/NABL accredited labs to provide their scope and validity. CIB&RC will maintain a list of NABL/GLP accredited labs and shall notify it on official website. The data generated by those enlisted GLP/NABL accredited labs shall only be acceptable.

3. The above guidelines will come into effect from the date, the list is placed on official website of the Directorate.
